LETTER FROM EXECUTIVE DIRECTOR

It has been a very big year for Got Your Six Support Dogs. We launched our capital campaign, "The Salute to Service Campaign", which Purina Dog Chow is serving as the lead supporter of. Our goal is to raise \$750,000 and we have raised over half of it so far. We finally have a place to call home, as we purchased our own 10,334 square-foot building in Maryville, III. We have successfully completed half of the renovations of the building with plans to have renovations completed by the end of 2021.



We also have traveled to Capital Hill twice to lobby Congress to make service dogs more readily available to veterans. We will continue to provide veterans and first-responders dealing with PTSD and/or sexual trauma with service dogs. And, we also plan to begin serving our communities with dog-training courses, as well as various mental health programs and educational courses. Our goal is to serve as a safe-haven for those in need and to connect individuals with man's best friend, dogs.

Our team has doubled the amount of dogs trained in the past year.

Looking back, we have accomplished so much thanks to our wonderful donors and sponsors who continue to support us and rally for our mission. Looking forward, we have so much more to do. Our veterans and first responders need us. They have had our backs, and it is time for us to have theirs.


A **service dog** is a dog that is individually trained to do work or perform tasks for the benefit of an individual with a disability, including a physical, sensory, psychiatric, intellectual, or other mental disability.

It costs approximately \$25,000 to train a service dog:

- \$15,000 for Specialized Dog Training
- \$500 for Crates and Beds
- \$750 for Grooming
- \$750 for Veteran Meals During Placement Program
- \$2,250 for Veteran Hotel Stay During Placement Program
- \$2,500 for Veteran Therapist, Workshop and Supplies Expenses



PROGRAM GROWTH




'EACH YEAR'S DATA IS A CUMULATIVE TOTAL FROM ONE YEAR TO THE NEXT.

PROGRAM OUTCOMES

The class of 2019 was given the **Short Post-Traumatic Stress Disorder Rating Interview (SPRINT) survey** before their arrival to the program, and again six months after completing the program. **The results are shown below.**


22%	improvement in mitigating unwanted memories, nightmares, or reminders of traumatic event.
18%	improvement in effort made to avoid thinking or talking about the event.
21%	increase in enjoyment of activities, spending time with others, and experiencing feelings.
41%	improvement in sleep, concentration, jumpiness, irritability, or feeling watchful.
29%	improvement in pains, aches, and tiredness.
39%	improvement of PTSD symptoms interfering with work and daily activities.

Eddie, Marines



Now I am able to go out to eat without constantly checking for the fastest escape route or sizing up the people around me to figure out which one would be the most likely threat. I can walk through a store with people without worry if I would have to

fight my way out.

Because of Paladin's unique looks, especially his eyes, which draws people's attention to him, I am now able to manage talking to people (for a limited time) without as much anxiety building up. He has been extremely helpful while dealing with the Veteran's Administration Health Care System. He has attended every compensation and pension hearing with me since we were paired up and has gotten me through them without me exploding on the examiner. By far, Paladin is the best medication I have ever received from any of my doctors!" - Eddie

"I received Jacie on Oct 2nd, 2017 from GYSSD. In the two plus years we have been a team, my life has steadily and healthily changed for the better. As a result of GYSSD and Jacie's presence in my life, I have reduced my dependency on medication, withstood several relational trials, seen one child off to college, successfully accomplished a terminal academic achievement, and most importantly: learned to be here and now despite my CPTSD. Jacie's steadfast stability and attentiveness have aided me in facing life's challenges head on with peace rather than fear and anger." - Lonnie

Kurt, Navy



"Paul has allowed me to use my PTSD/TBI to the point at which I am enrolled in Graduate School on track for a Masters in Social Work. I am also active in volunteering in veteran causes - for example Veterans Treatment Court where I serve as a Mentor for veterans in the court system. I have become licensed as a substitute teacher and work with at-risk teens at a Regional Alternative School.

Since receiving Paul, I am able to socialize with others in all settings - my hyper vigilance has decreased dramatically, and I am now "free" to shop, attend movies, eat out, etc.

Another key impact I have experienced is that I am no longer needing the multitude of medications I had been taking for many years. The absence of these medications has made a profound difference in the way I am able to live my life. Emotions that were once held in check are now flowing again. I can laugh (and cry) - neither of which I was able to do in the years leading up to Paul." - Paul

We have exciting things in store for 2020 now that we finally have a place to call home!

- Our goal is to complete the renovations of our 10,334 square-foot building located at 6 Schiber Court in Maryville, IL.
- Once renovations have been completed, we would like to open up a community classroom for other local nonprofits to utilize and connect with one another and the community.
- We plan to begin offering dog training classes to the public to generate a sustainable income to offset program costs.
- With our new facility, our goal is to increase the number of dogs trained annually by 25%.
- We also plan to have a full-time therapist on staff, and provide various mental health programs to the local community, such as mental health first aid, trauma yoga, art therapy, support groups and more.

The entire Got Your Six Support Dogs team is so excited for what is to come and is so grateful for our generous donors and sponsors who continue to support us.

Our mission remains to continue to provide veterans and first-responders suffering from PTSD and/or sexual trauma with life-saving support dogs.


